# Logger Compliance Insight Package for NERC

ArcSight Logger is a storage solution optimized for extremely high event throughput. An *event* is a time-stamped log entry, either sent by protocols such as syslog, or appended to a log file. Logger receives and stores events, and can optionally forward selected events.

Logger Compliance Insight Package (CIP) for NERC is a stand-alone package that is installed on ArcSight Logger, and leverages ArcSight Logger's litigation-quality, long-term repository of log and event data to facilitate NERC compliance using ArcSight Logger's reporting, alerting, and dashboard capability.

Note: Version 1.01 of ArcSight Logger CIP for NERC provides a new software installer component, which enables you to install the package on ArcSight Logger 6.6 or later. For information about supported versions of ArcSight Logger, see ["Minimum Requirements" below](#).
