Identity Intelligence provides interactive dashboards and reporting capabilities for identity governance data. It provides the details in the form of dashboards and reports to monitor and analyze. Also, it provides the monthly active user information for the available applications.

Identity Intelligence is an analytics solution. The analytics repository in the Identity Intelligence stores and processes the governance data. This processed data is represented in the dashboards to monitor and analyze the governance activities. The reporting capability of the product enables running reports and allows sharing of the information with the stakeholders.

### **Data Archiving and Purging the Activity Data**

Data Archiving capability for the activity data, empowers to store historical records for compliance and auditing purpose. Purging the obsolete data helps to optimize system performance and adhere to data retention policies. This feature enables a streamlined approach to managing and maintaining relevant activity data within the system.

The activity data that is older than thirteen months gets archived, excluding the current month and is automatically purged after two years of archival.

### **Displaying User Activity Data**

User activity data from the Identity Access Management product sources, such as Password Management, Advanced Authentication, and Identity Governance and Administration is processed by Identity Intelligence. This processed data is utilized to generate the reports. The reports quantify the frequency of user interactions to various features of the application, thereby providing insights into user subscription information.

# Labels are Displayed Upside Down in the Accounts Relationship with Category Widget

Issue: A few labels are displayed upside down in the Accounts Relationship with Category widget.

Workaround: None.

# 'Preparing Report' Spinner Gets Displayed while Switching from One Report to Another Report

**Issue**: When you click a report and try clicking another one while the previous report is still loading causes a delay in loading the report.

Workaround: Refresh the page.

# Add to Queue Option is not Displayed in the Report Loading Page

**Issue**: The Add to Queue option enables to add a report to the queue and view the results later for the long running report. The option is not displayed currently due to technical limitation.

Workaround: None.
