Support for Windows 11

NetIQ SecureLogin now supports Windows 11 24H2.

Resolved Issues

The following issues have been resolved in SecureLogin 9.2.0.1:

ID	Module	Description
390022	Client General	Picklist displays white background column in the column header.
490118	Client General	Every SecureLogin cache refresh increases memory usage on slbroker.
656314	Client General	SecureLogin wizard does not save script using the default options in Active Directory mode.
660020	Datastore - AD	When a user logs in using UPN, SecureLogin prompts to re-enter the password.

Known Issues

The following issues are currently being researched for SecureLogin 9.2.0.1:

Importing in eDirectory Mode Fails

Issue: NetIQ SecureLogin displays incorrect passphrase question after importing in eDirectory mode and fails to load even after providing correct answer.

Workaround: No workaround.

Single Sign-On is Not Seamless if MPR Notification is Not Configured or Disabled

Issue: If MPR notification is not enabled in Windows 11 24H2, single sign-on is not seamless.

Workaround: Enable MPR notification in group policy.

NOTE: MPR notification is disabled by default in Windows 11 24H2.
