The *Novell BorderManager™ Enterprise Edition 3.5*, *BorderManager™ Firewall Services 3.5*, *BorderManager™ VPN Services 3.5*, and *BorderManager™ Authentication Services 3.5* software and accompanying documentation ("Software") are protected by the copyright laws and treaties of the United States (U.S.) and other countries. In addition, possession and use of the Software are subject to the terms of this Software License ("License"). By exercising Your rights to make and use copies of the Software, You agree to be bound by the terms of this License. The Software is licensed to You, not sold.

The Software contains various software programs with different license rights. Some of the programs are licensed for use on a single computer (network server), whereas some are licensed for use on several machines (workstations). The type of license that applies depends on the following definitions and the permitted uses specified in the documentation accompanying the Software.

**Client Software** means NetWare Client, Client VPN, or other software programs licensed to You as part of the Software that operate on an intelligent, single-user device, permitting that device to access the shared resources provided by the Host Software.
