

NetWare® 4.11 Software License

General Terms

The *NetWare 4.11* software, with which Novell has bundled the separate NetWare Web Server 2.5 and Netscape Navigator computer programs, and accompanying documentation (respectively "Software" and "Documentation") you have acquired are protected by the copyright laws of the United States and international copyright treaties. In addition, the possession and use of the Software and Documentation is subject to the restrictions contained in this License.

The Software contains various software programs with different license rights. Some of the programs are licensed for use on a single computer (network server) whereas some are licensed for use on several machines (workstations). The type of license that applies depends on the following definitions and the permitted uses specified in the documentation accompanying the Software.

Client Software means the software programs provided as part of the Software that operate on an intelligent, single-user device, permitting that device to access the shared resources provided by Host Software.

Host Software means the software programs provided as part of the Software that are designed to operate on a single computing device, providing access to the shared resources attached to that computer. Host Software may contain technical limitations that limit use of the Host Software to a specified number of computers running Client Software.

NLM Software means the NetWare Web Server Software which is capable of running on the Host Software.

User Count means the number of users specified on the uniform product code label provided on the outside packaging of the *NetWare 4.11* product.

Connection Management Software means computer programs provided as part of the Software which monitor the number of connections permitted under this License and which are designed to prevent more connections than the number of licensed connections specified by the User Count.

License. Subject to the terms and conditions of this License, Novell grants to you a non-exclusive, non-transferrable right to (a) use the Host Software on a single computing device (network server), (b) provide you do not receive any direct payment, to make, and distribute internally within your organization, an unlimited number of copies of the Client Software, and (c) simultaneously use up to the number of copies specified by the User Count of the Client Software; (d) use the NLM Software on the Host Software; (e) provided you do not receive any direct payment, to make, and distribute internally within your organization, one (1) copy of the Netscape Navigator software and place that copy on single user computing devices running Client Software in support of Host Software for use: (i) primarily in support of NLM Software; and, (ii) for Internet or World Wide Web access. You may not modify the Connection Management Software to increase the number of connections supported by the Host Software. Further, you may not use any device, process or computer program in conjunction with the Host Software which increases, either directly or indirectly, the number of connections to the Host Software. Novell reserves all rights not expressly granted to you.

Term. This License will become effective on the date you acquire the Software and will remain in force until terminated. You may terminate this License at any time by destroying the Documentation and the Software together with all copies and adaptations. This License shall also automatically terminate if you breach any of the terms or conditions. You agree to destroy the original and all adaptations or copies of the Software and Documentation, or to return them to Novell upon termination of this License.

Governing Law. Except as otherwise restricted by law, this License shall be governed by, and interpreted in accordance with, the laws of the State of Utah of the United States of America, without regard to laws of Utah governing conflicts of law. Furthermore, it is understood that this License shall be treated as though it were executed in Utah County of the State of Utah. The parties agree that any action relating to this License shall be instituted and prosecuted in the courts of competent jurisdiction of the State of Utah.

Entire License. This License sets forth the entire understanding and License between you and Novell and may be amended only in a writing signed by both parties. NO VENDOR, DISTRIBUTOR, DEALER, RETAILER, SALES PERSON OR OTHER PERSON IS AUTHORIZED TO MODIFY THIS LICENSE OR TO MAKE ANY WARRANTY, REPRESENTATION OR PROMISE WHICH IS DIFFERENT THAN, OR IN ADDITION TO, THE REPRESENTATIONS OR PROMISES OF THIS LICENSE.

Waiver. No waiver of any right under this License shall be effective unless in writing, signed by a duly authorized representative of the party to be bound. No waiver of any past or present right arising from any breach or failure to perform shall be deemed to be a waiver of any future right arising under this License.

Severability. If any provision in this License is invalid or unenforceable, that provision shall be construed, limited, modified or, if necessary, severed, to the extent necessary, to eliminate its invalidity or unenforceability, and the other provisions of this License shall remain unaffected.

Export. Novell can only make the Software available pursuant to a valid export license. Consequently, Novell will refund any fees paid to you if it is unable to obtain an export license to ship the Software to you. Your sole remedy for Novell's failure to obtain an export license is a refund.
