

PlateSpin Forge® 3 Novell® Software License Agreement

PLEASE READ THIS AGREEMENT CAREFULLY. BY INSTALLING, DOWNLOADING OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE WITH THESE TERMS, DO NOT DOWNLOAD, INSTALL OR USE THE SOFTWARE OR HARDWARE AND, IF APPLICABLE, RETURN THE ENTIRE UNUSED PACKAGE TO THE RESELLER WITH YOUR RECEIPT FOR A REFUND. THE SOFTWARE MAY NOT BE SOLD, TRANSFERRED, OR FURTHER DISTRIBUTED EXCEPT AS AUTHORIZED BY NOVELL.

This Novell Software License Agreement ("Agreement") is a legal agreement between You (an entity or a person) and Novell, Inc. ("Novell") and sets forth the terms and conditions governing Your use of software embedded in, supplied with or otherwise forming a part of the PlateSpin Forge server appliance ("Server Appliance"), any media and accompanying documentation (collectively the "Software") as well as the hardware included in the Server Appliance and any updates and warranty repairs thereto ("Hardware"). The Software is protected by the copyright laws and treaties of the United States ("U.S.") and other countries. Any update or support release to the Software that You may download or receive that is not accompanied by a license agreement expressly superseding this Agreement is Software and governed by this Agreement. If the Software is an update or support release, then You must have validly licensed the version and quantity of the Software being updated or supported in order to install or use the update or support release.

The Server Appliance may include or be bundled with other software programs licensed under different terms and/or licensed by a licensor other than Novell. Use of any software programs accompanied by a separate license agreement is governed by that separate license agreement. Any third party software that may be provided with the Software is included for use at Your option.

DEFINITIONS

"Appliance Host" means the hypervisor which hosts the Software as well as the replicated Workloads.

"Management VM" means the management virtual machine containing the Software.

"Migration" means to move or copy a Workload from one computer to another.

"Operating System" means software that controls the operation of a computer and directs the processing of programs (as by assigning storage space in memory and controlling input and output functions). An Operating System may be installed either directly on a computer system or within a virtual machine. For example, a virtual machine server that hosts four virtual machines represents five Operating Systems.

"Software Product License Key" means the mechanism that enables You to install and use the Software subject to the restrictions set out in this Agreement and may be a printable digital key, a non-printable file or any other mechanism used by Novell for license activation purposes.

"Source Computer" means the computer that contains the Workload that You desire to protect.

"Target Computer" means the computer that receives the Workload, whether in the form of a physical computer without an Operating System or a physical computer which is running a virtual operating environment.

"Workload" means a unit of software that may be (a) installed and can run on a physical computer that has no Operating System software loaded onto it, or (b) installed and can run in a specialized operating environment, typically understood as a virtual operating environment, that allows the Operating System to run as an independent computer in the presence of other such independent computers, known as virtual machines. This includes any encapsulated form of such unit of software. A Workload contains the Operating System files necessary to "boot up" a standard computer and run the associated applications and data.

"Workload Backup Copy" means a copy of a Workload, which may exist in any form (either encapsulated in an image file or installed on a computer) but it may not be operating concurrently with the Workload to perform the normal tasks of the Workload.

Title and Delivery

Delivery.

For delivery from the U.S. to destinations within the U.S.A., delivery terms are FOB Novell's Dock (INCOTERMS 2000). Novell will ship ground only and prepay freight from Novell's Dock to Your forwarder or named destination. All other freight arrangements will be billed to You.

For delivery from the U.S. to destinations outside the U.S.A., delivery terms are DDU-POE (Delivery Duty Unpaid - Port of Entry) as defined in INCOTERMS 2000. Novell will select a carrier and will prepay shipping and handling charges. You will be responsible for all applicable import duties and value added tax, goods and services tax, or other similar taxes and fees.

For delivery within Europe, the Middle-East and Africa ("EMEA"), delivery terms will be Carriage Paid To (C.P.T.) Destination, as defined in INCOTERMS 2000. Novell will select a carrier, prepay the freight and invoice You for freight and any handling costs. Destinations for E.U. countries will be Your nominated delivery point; for non-E.U. countries, destination will be the point of import. The term C.P.T. does not include the payment by Novell of taxes or any applicable import duties.

Title & Risk of Loss. *For shipment within the United States,* title to any deliverables, exclusive of Novell's rights to intellectual property, and risk of loss will pass to You upon delivery to Your carrier. *For shipments from the U.S. to outside the U.S.,* title to and risk of loss will remain with Novell until the shipment arrives at the importing country's entry port (or at a bonded warehouse within Canada or Mexico if You so request shipment). *For shipments within EMEA* (i.e. originating in Ireland), title to and risk of loss

passes to You at the Irish shipment point. If You insure shipment, the insurance will protect Novell's interest until title passes as set forth above. Notwithstanding the above provisions, no title to Master Software is transferred to You.

LICENSED USE

Commercial Software.

Provided that You comply with all of the terms and conditions of this Agreement and the License Grant Restrictions below, Novell grants You a non-exclusive, non-transferable license, without the right to sublicense, to use the Software in object code form, solely in conjunction with Your use of the Server Appliance, in accordance with the Software License Key associated with the Software. You must purchase the appropriate number of licenses for the number of Workloads and the applicable model of Server Appliance.

1. You are permitted to create a Workload Backup Copy to a single Target Computer and to update that Workload Backup Copy an unlimited number of times.
2. You may assign the license to a specific Workload (an "Assigned Workload"), whatever form such Workload takes; provided however that once assigned, the Workload license applies only to the Assigned Workload until such Assigned Workload is permanently disabled or decommissioned (which would include discarding the computer or deleting and disassembling all the components that constitute the Assigned Workload) after which the Workload license can be re-assigned to another Workload. You are permitted to re-assign (or Workload transfer) any or all of the Workload licenses You have purchased provided that the Assigned Workload is permanently disabled or decommissioned. In no circumstance other than as described above may You assign a Workload license to a Workload and then temporarily reassign it to another Workload (such as a Workload Migration).
3. You may only use the virtual machines contained within the Server Appliance. You may not create additional virtual machines in order to perform functions other than to protect Workloads on the Server Appliance.
4. You may only use the Management VM for the purposes stated herein and shall not use the Management VM for any other purpose including but not limited to: file sharing, application server, print server and general purpose web server.
5. Other than the Software, the hypervisor and any system utilities, You agree not to install or use any third party software on the virtual machines in the Server Appliance and not to install any third party software on the Appliance Host.
6. You are prohibited from adding or removing the following elements to or from the Server Appliance: memory, hard drive, CPU and network cards, except in the case of hardware updates, enhancements and/or modifications to the Software and/or the Server Appliance.

The Software License Key may be a printable digital key, a non-printable file, or any other mechanism used by PlateSpin for license activation purposes. You agree not to override or attempt to override the Software License Key.

The Software facilitates the distribution of additional operating systems and applications ("Guest Operating Systems and Applications") to run on a computer system. You must have a licensed copy of each Guest Operating System and Application for such use. You must have licensed any Operating System components the Software installs as part of the conversion process, such as HALs and Kernel modules. You agree to indemnify and hold Novell harmless against any damages, costs (including legal attorneys' fees and costs) or other liability arising from claims resulting from Your failure to obtain any such required licenses. Novell shall have the right to participate at its expense in the defense of any such dispute.

Specific Third Party Software. Novell's contractual arrangements require that Novell include the following provisions.

1. The Software contains Third Party Software referred to as (i) 'Microsoft SQL Server 2005 (CAL Versions), (ii) Microsoft Windows Server 2003 Standard R2 with the Server Appliance Software Version 3.1), and (iii) Microsoft Windows Preinstallation Environment. Your use of this Third Party Software is subject to the terms and restrictions set out in the Third Party Software end user license agreements set forth in Schedules A, B and C. In addition, You acknowledge that Microsoft WINPE ISO disk contains a security feature that will cause a computer system to reboot without prior notification to the end user after 24 hours of continuous use. You shall not attempt to disengage, block or otherwise circumvent this feature.
2. The Software includes software licensed from VMware Inc. You agree not to de-compile, disassemble, reverse engineer or otherwise attempt to derive source code from the Product, in whole or in part (or in any instance where the law permits any such action, You agree to provide VMware at least forty-five (45) days advance written notice of Your belief that such action is warranted and permitted and provide VMware with an opportunity to evaluate if the law's requirements necessitate such action). You agree not to allow access for permit use of the VMware product by any user other than the Forge server or modify or create derivative works based upon the VMware product.

Evaluation Software. If PlateSpin Forge is provided to You for evaluation purposes, then Your license to use the Software is limited solely to internal evaluation purposes and in accordance with the terms of the evaluation offering under which You received the Software and expires 30 days from installation (or such other period as may be indicated within the evaluation Software License Key). Upon expiration of the evaluation period, You must discontinue use of the Software and return the Server Appliance as agreed to in Your applicable Evaluation Agreement.

RESTRICTIONS

License Restrictions. Novell reserves all rights not expressly granted to You. The Software is licensed for Your internal use only. You may not (1) reverse engineer, decompile, or disassemble the Software except and only to the extent it is expressly permitted by applicable law; (2) modify, alter, rent, timeshare host or lease the Software or sublicense any of Your rights under this Agreement; or (3) transfer the Software or Your license rights under this Agreement, in whole or in part, without written permission by Novell.

Upgrade Protection. If You purchased upgrade protection or maintenance under a Novell program for this Software, the upgrade protection or maintenance only entitles You to upgrades of the Software as a whole and does not entitle You to upgrades of any component programs or products bundled with the Software or any individual products included in a suite if the Software is licensed

as a suite of products. You may separately purchase upgrade protection for individual components of the Software if permitted by the applicable Novell policies and programs.

Upgrade Software. This section applies to You if You have purchased the Software based upon upgrade pricing. "Original Product" means the product from which You are upgrading. You are authorized to use the Software only if You are the authorized user of the Original Product and You meet the following conditions: (1) You have acquired the right to use the Software solely to replace the Original Product that You acquired legally and that is qualified to be upgraded with the Software under the Novell policies existing at the time You acquired the Software; (2) You installed and used the Original Product in accordance with the terms and conditions of the applicable license agreement; and (3) You will not sell or otherwise transfer possession of the Original Product.

Support. Novell has no obligation to provide support unless You purchase an offering that expressly includes support services. If You make such a purchase and no separate agreement specifically applies to the support services, then the terms of this Agreement will govern the provision of such support services ("Services"). OWNERSHIP

No title to or ownership of the Software is transferred to You. Novell and/or its licensors retain all right, title and interest in and to all intellectual property rights in the Software and Services, including any adaptations or copies thereof. You acquire only a conditional license to use the Software.

LIMITED WARRANTY

For ninety (90) days from Your date of purchase, Novell warrants that (1) any media on which the Software is delivered is free from physical defects; and (2) the Software will substantially conform to the documentation accompanying the Software. If the defective Server Appliance is returned to Novell or if You report the nonconformity to Novell within ninety (90) days from the date of purchase, Novell will at its sole discretion either resolve the nonconformity or refund the license fees You paid for the Server Appliance upon its return. Any unauthorized use or modification to the Software voids this warranty. If You have purchased a Hardware warranty from Novell, then the terms of the warrant may be found at www.platespin.com/support/policy. THE FOREGOING HARDWARE AND SOFTWARE WARRANTY ARE YOUR SOLE AND EXCLUSIVE REMEDY AND ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. (The foregoing warranty does not apply to Software provided free of charge. SUCH SOFTWARE IS PROVIDED "AS IS" WITHOUT ANY WARRANTIES OF ANY KIND.)

Services. Novell warrants that any Services purchased will be supplied in a professional manner in accordance with generally accepted industry standards. This warranty will be effective for ninety (90) days following delivery of the Services. Upon any breach of this warranty, Novell's only obligation is to either correct the Services so that they comply with this warranty or at its option refund the amount You paid to Novell for the portion of the Services that fail to comply with this warranty. As files may be altered or damaged in the course of Novell providing technical services, You agree to take appropriate measures to isolate and back up Your systems.

Transfer. This Agreement may not be transferred or assigned without the prior written approval of Novell.

This Agreement is governed by the laws of the State of Utah, U.S. Any action at law relating to this Agreement may only be brought before the courts of competent jurisdiction of the State of Utah. If, however, Your country of principal residence is a member state of the European Union or the European Free Trade Association, this Agreement is governed by the laws of that country, and any action at law may only be brought before a court of competent jurisdiction of that country.

Entire Agreement. This Agreement sets forth the entire understanding and agreement between You and Novell and may be amended or modified only by a written agreement agreed to by You and an authorized representative of Novell. Export Compliance. Any products or technical information provided under this Agreement may be subject to U.S. export controls and the trade laws of other countries. The parties agree to comply with all export control regulations and to obtain any required licenses or classification to export, re-export or import deliverables. The parties agree not to export or re-export to entities on the current U.S. export exclusion lists or to any embargoed or terrorist countries as specified in the U.S. export laws. The parties will not use deliverables for prohibited nuclear, missile, or chemical biological weaponry end uses. Schedule A

MICROSOFT SOFTWARE LICENSE TERMS

MICROSOFT® SQL SERVER™ 2005 (CAL VERSIONS)

These license terms are an agreement between you and *Microsoft*. Please read them. They apply to the software included on this server. The software also includes any separate media on which you received the software.

The software on this device includes software licensed from Microsoft Corporation or its affiliate.

The terms also apply to any Microsoft

- updates,
- supplements,
- Internet-based services, and
- support services

for this software, unless other terms accompany those items. If so, those terms apply. If you obtain updates or supplements directly from Microsoft, then Microsoft, and not Novell, licenses those to you.

This software does not transmit personally identifiable information from your server to Microsoft Corporation computer systems without your consent.

By using the software, you accept these terms. If you do not accept them, do not use the software. Instead, contact Novell to determine its return policy for a refund or credit.

As described below, using some features also operates as your consent to the transmission of certain standard computer information for Internet-based services.

If you comply with these license terms, you have the rights below.

1. USE RIGHTS.

- *Server Software.* Server software provides functions or services on this server. You may use, access, boot from, display and run one copy of the server software only on this server. You may reinstall the server software on this server. You may not use the server software or its components on another server.
- *Assignment of the License to this Server.* The license for the server software is permanently assigned to the server with which the server software was distributed. If the server has multiple hardware partition(s) or blade(s), you must permanently assign that license to one of the hardware partition(s) or blade(s). You may assign other software licenses to the same server, but you may not assign the same license to more than one server. Each hardware partition or blade is considered to be a separate server.

2. ADDITIONAL LICENSING REQUIREMENTS AND/OR USE RIGHTS.

- a. **Specific Use.** Novell designed this server for a specific use. You may only use the software for that use.

You may not use the software to support additional software programs or functions, other than utilities or similar software used solely for administration, performance enhancement and/or preventative maintenance of this server.

b. **Client Access Licenses (CALs).**

i. In addition to the server software license, you must acquire the appropriate CAL for each device or each individual person ("User") that accesses the server software directly or indirectly.

- The edition of the CAL must correspond to the edition of the Licensed Product that the device or User will access. For example, for SQL Server 2005 Enterprise Edition software, you must acquire CALs for SQL Server 2005 Enterprise Edition. You may not use CALs for SQL Server 2005 Standard Edition or SQL Server 2005 Workgroup Edition.

- You do not need a CAL for the server.

ii. *Types of CALs.* There are two types of CALs: device CALs and User CALs. Each device CAL permits one device, used by any User, to access instances of the server software on your licensed servers. Each User CAL permits one User, using any device, to access instances of the server software on your licensed servers. You may use a combination of device CALs and User CALs.

iii. *Reassignment of CALs.* You may

- permanently reassign your device CAL from one device to another, or your User CAL from one User to another; or
- temporarily reassign your device CAL to a loaner device while the first device is out of service, or your User CAL to a temporary worker while the User is absent.

c. **Tools.** You may run or otherwise use the additional software listed below ("Tools") on the server and any number of devices. You may only use the Tools internally with your use of the server software.

d. **Included Microsoft Programs.** The software contains other Microsoft programs. The license terms with those programs apply to your use of them.

e. **Runtime-Restricted Use Software.** The software is "Runtime-Restricted Use" software. You may only use the software to run the Integrated Application.
